SECTION 7 OF THE NLRA, FEDERAL LAW, GIVES YOU THE RIGHT TO:

- · Form, join, or assist a union;
- · Choose a representative to bargain with your employer on your behalf;
- · Act together with other employees for your benefit and protection;
- · Choose not to engage in any of these protected activities.

WE WILL NOT do anything to prevent you from exercising the above rights.

WE WILL NOT formulate and implement irrational, arbitrary, and discriminatory criteria to guide the designation of the recipients of the Grievance AG21305 (May 22, 2015); Grievance AA216066 (July 18, 2016); Grievance AA217069 (March 14, 2017); and Grievance AA218105 (February 9, 2018) settlement monies.

WE WILL NOT refuse to provide bargaining unit members who are represented by Detroit District, Area Local 295, American Postal Workers Union (APWU), AFL-CIO (Union), with an explanation of how grievance settlement disbursement amounts were arrived at.

WE WILL NOT in any manner restrain or coerce you in the exercise of your rights under Section 7 of the Act.

WE WILL conduct mandatory training sessions for all Union officers, other officials, and stewards regarding the requirement to formulate and implement rational, non-arbitrary, and non-discriminatory criteria for designating the recipients of grievance settlement monies and notify Region 7 in writing after conducting each session as well as providing a list of attendees and the instructor at each session.

WE WILL formulate and implement rational, non-arbitrary, and non-discriminatory criteria for designating the recipients of the Grievance AG21305 (May 22, 2015); Grievance AA216066 (July 18, 2016); Grievance AA217069 (March 14, 2017); and Grievance AA218105 (February 9, 2018) settlement agreement monies.

WE WILL make employees whole, with interest, for any losses they suffered due to our failure to designate the recipients of the Grievance AG21305 (May 22, 2015); Grievance AA216066 (July 18, 2016); Grievance AA217069 (March 14, 2017); and Grievance AA218105 (February 9, 2018) settlement monies in accord with rational, non-arbitrary and non-discriminatory criteria.
